Procurement of Works

This Invitation for Tenders follows the General Procurement Notice for this project, which was published, on the EBRD website, Procurement Notices ([www.ebrd.com](http://www.ebrd.com)) on November 3, 2015.

**Municipal Development Fund of Georgia**, hereinafter referred to as “the Employer”, intends using part of the proceeds of a loan from the European Bank for Reconstruction and Development (the Bank) towards the cost of **Kobuleti Municipal Water Project**.

The Employer now invites sealed tenders from contractors for the following contract to be funded from part of the proceeds of the loan for: **Completion of construction of Kobuleti Waste Water Treatment Plant (WWTP) – Civil Works**.

Construction site is located in West Georgia, Adjara AR, 350 km west from Tbilisi and comprise territory of Kobuleti Municipality. Access to the site is possible via Tbilisi-Samtredia-Batumi Highway or Railway.

Delivery of mechanical equipment is not part of the scope of Contractor except the delivery of the "chain scraper" and the "overflow through" of secondary clarifier.

The envisaged period for the completion of the Works: 9 months.

Tendering for contracts to be financed with the proceeds of a loan from the Bank is open to firms from any country.

To be qualified for the award of a contract, tenderers must satisfy the following minimum criteria:

(a) The Tenderer has an average annual turnover over the last 3 (three) years of not less than **EUR 3,700,000.00 (Three Million Seven Hundred Thousand)** equivalent;

(b) Each Tenderer must have access to, or has available, liquid assets, unencumbered real assets, lines of credit, and other financial means sufficient to meet the construction cash flow for the contract for a period of **2 (two)** months, estimated as not less than **EUR 400,000.00** equivalent, taking into account the applicant's commitments for other contracts.

(c) Successful experience as prime contractor in execution of **at least 2 (two) projects** of a nature and complexity comparable to proposed contract within the **last 5 (five) years** with a value of at least **EUR 1,500,000.00 (One point Five Million Euro) equivalent**. In addition, the tenderers shall have the following specific experience: Earthworks – 4,000 m<sup>3</sup>, Concrete works – 3,000 m<sup>3</sup>, Installation of reinforcement – 320 ton, in any one year.

(d) Participation of joint ventures, consortia and associations (“JVCA”) is permitted. In case the tender is submitted by a JVCA, the tenderer shall meet the following criteria:

- (i) the lead partner shall meet at least 40% of criteria for the average annual turnover and financial resources specified above;
- (ii) all other partners shall each meet at least 25% of criteria for the average annual turnover and financial resources specified above;
- (iii) all JVCA partners combined shall meet 100% of all qualification criteria.

The tender documentation will be distributed electronically by uploading it via [www.wetranfer.com](http://www.wetranfer.com) system.

Tenders must be delivered to the office at the address below on or before **February 11, 2016 at 15:00** (local time), at which time they will be opened in the presence of those tenderers' representatives who choose to attend.
