1. Minimum average annual turnover calculated as total certified payments received for contracts in progress or completed, within the last five (5) years shall be:

2. The Bidder must demonstrate access to, or availability of, financial resources such as liquid assets, unencumbered real assets, lines of credit, and other financial means, other than any contractual advance payments to meet the following cash-flow requirement:

3. Participation as contractor, management contractor, or subcontractor, in at least two (2) contracts within the last five (5) years that have been successfully and substantially completed and that are similar to the proposed Works, each with a value of at least:
