Municipal Development Fund of Georgia intends using the proceeds of a loan from the Nordic Environment Finance Corporation (NEFCO) and grant from the Eastern Europe Energy Efficiency and Environment Partnership (E5P) for the implementation of the Investment Project "Energy Efficiency Improvements in Public Buildings and the use of renewables and alternative energy in Georgia". The Project has a total estimated budget of EUR 4.7 MEUR aiming at implementing energy efficiency measures and including renewable energy sources in 26 public buildings in Georgia, having an area of approximately 70 000 m² in the following locations:

- Kvareli: 1 building
- Kvemo Bolnisi: 1 building
- Lagodekhi: 1 building
- Mtskheta, Arsha: 1 building
- Mtskheta, Goristsikhe: 1 building
- Ozurgeti : 1 building
- Rustavi: 2 buildings
- Samtske, Didi Arakali: 1 building
- Tbilisi: 7 buildings
- Telavi: 1 building
- Zugdidi: 2 buildings

The Project would require the implementation of the following measures, which would include designing, supply of goods and implementation of works:

- Thermal insulation of roofs and walls
- Replacement of windows or glass facades

- Installation of new ventilation systems
- Installation and replacement of boilers
- Thermal insulation of pipes
- Installation of thermostatic valves and other automation control
- Installation of heat pumps
- Installation of solar collector and solar PV systems
- LED lamps for indoor lighting, etc.

Tendering for implementation of the above listed measures is expected to begin Q4 of 2018 and finish in Q4 of 2020.
