- 1. Georgia has received a loan from the European Investment Bank toward the cost of Water Infrastructure Modernization Project II, and it intends to apply part of the proceeds of this credit to payments under the Contract for Supply of Double Cab Trucks for *The United Water Supply Company of Georgia* (Contract # EIB/WIMPII/G/ICB/03).
- 2. *LEPL Municipal Development Fund of Georgia* now invites sealed bids from eligible and qualified bidders for Supply of 15 units of Double Cab Trucks.

Delivery period is from 90 to 120 days.

- 3. Bidding will be conducted through the International Procurement procedures specified in *EIB's Guidelines: Guide to Procurement, June 2011* and is open to all bidders from Eligible Source.
- 4. Interested eligible bidders may obtain further information from *Municipal Development Fund of Georgia*, *Mr. Giorgi Somkhishvili*, *Executive Director*, <u>procurement@mdf.org.ge</u> and inspect the Bidding Documents at the address given below from Monday to Friday 10:00 to 18:00 hours.
- 5. Bids should be submitted for one contract. All items will be evaluated together and the Contract will be awarded to the bidder who has the lowest evaluated responsive bid.

If the bidder with the lowest evaluated bid for contract meets the all criteria specified in Items ITB 11.1 (g) and 11.1(h) (i) of the Bidding Data Sheet, the Bidder will be awarded contract.

## Qualifications requirements include:

To be qualified for award the bidder shall meet the following criteria and present the documents to confirm that as a minimum:

- (a) The Bidder to have undertaken, in the last five (5) years, at least one (1) similar contract including supply of at least twelve (12) units of cab trucks and such goods have been in successful use for at least one (1) year. (To confirm that, bidders should submit acceptance certificate issued by a purchaser from a buyer/end user confirming that goods have been supplied and a letter from buyer/end-user confirming that goods have been in successful operation for at least 1 year);
- (b) The Bidder shall demonstrate that it has (or has contracted) a service organization, duly authorized by goods' manufacturer, set up in Georgia, equipped, ready and capable of carrying out the Supplier's service, maintenance, repair spare parts stocking and warranty obligations for particular items as described in Section VII: Schedule of Requirements. Service provider should have at least 3 years experience of service of the goods produced by the manufacturer submitted in the Bid proposal. (To confirm that, service organization should submit acceptance certificates issued by a purchaser from a buyer/end user confirming that goods

have been serviced in Georgia and a letter from buyer/end-user confirming that services provided are at the highest level possible).

A margin of preference for certain goods manufactured domestically "shall not" be applied. Additional details are provided in the Bidding Documents.

6. A complete set of Bidding Documents in English language may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non refundable fee GEL 200 or equivalent in a convertible currency plus currier expenses if a bidder would like the Bidding documents to be sent by Courier. On request, against a faxed copy of the evidence of the remittance, the Bidding Documents may be sent by courier service if the transport is previously ordered by the Bidder in his country. The Borrower bears no responsibility for the delivery in such a case.
