1. Georgia has received a loan from the European Investment Bank (hereinafter referred to as "the Bank") toward the cost of Water Infrastructure Modernization Project II, and it intends to apply part of the proceeds of this credit to payments under the Contract for Rehabilitation of Kareli Water Supply System for *The United Water Supply Company of Georgia* (Contract # EIB/WIMPII/W/NCB/09).
2. *LEPL - Municipal Development Fund of Georgia* now invites sealed bids from eligible and qualified bidders for works:

Rehabilitation of Kareli Water Supply System

Main works under the project are:

1. Soil excavation – 16,039 m³.
2. Backfilling of the local soil – 3,841 m³.
3. Arrangement of sand base and sand layer – 4,937 m³.
4. Backfilling of sand-gravel ballast – 2,150 m³.
5. Backfilling of road metal and ramming with pneumatic rammer – 3,300 m³.
6. Installation Polyethylene Pipes DN 20-160 SDR21 PN8 - 23,507 m.
7. Installation Steel Pipes D=108 - 21,921 m.
8. Chlorination building – 1pcs.
9. Repairing of reservoir watertight insulation – 804 m².
10. Installation of the new pump - 1pcs.
11. Restoration of asphalt pavement – 7,070 m²

The construction period is 7 (seven) months from start date of the works.

3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the EIB's *Guidelines: Guide to Procurement, June 2011* and is open to all bidders from Eligible Source.
4. Interested eligible bidders may obtain further information from *Municipal Development Fund of Georgia, Iliia Darchiashvili, Acting Executive Director, procurement@mdf.org.ge* and inspect the Bidding Documents at the address given below from Monday to Friday 10:00 to 18:00 hours.

5. Qualifications requirements include and are not limited to:
- (a) The minimum required average annual turnover of construction works for the successful Bidder in the last three years shall be: **GEL 4,900,000**;
 - (b) The minimum amount of liquid assets and/or credit facilities net of other contractual commitments shall be: **GEL 800,000**.
 - (c) A minimum number of similar contracts specified below that have been satisfactorily and substantially completed as a prime contractor, joint venture member, management contractor or sub-contractor between **1st January 2009** and application submission deadline: (i) **1 (one)** contract, of minimum value of **GEL 1,200,000**; or (ii) **2 (two)** contracts, each of minimum value **GEL 600,000** but with total value of all contracts equal or more than **GEL 1,200,000**.

A margin of preference for certain goods manufactured domestically “*shall not*” be applied. Additional details are provided in the Bidding Documents.

6. A complete set of Bidding Documents in *English language* may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non refundable fee *GEL 300* or equivalent in a convertible currency plus courier expenses if a bidder would like the Bidding documents to be sent by Courier. On request, against a faxed copy of the evidence of the remittance, the Bidding Documents may be sent by courier service if the transport is previously ordered by the Bidder in his country. The Bidder bears no responsibility for the delivery in such a case.

Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders’ representatives who choose to attend in person address below at 16:00 (local time), **September 8, 2014**.

All bids must be accompanied by a “Bid Security” of **GEL 29,000** (Twenty Nine Thousand) equivalent. A Bid-Securing Declaration is not required.
