Water Infrastructure Modernization Project II Rehabilitation of Tsalka Water Supply System

- 1. Georgia has received a loan from the European Investment Bank (hereinafter referred to as "the Bank") toward the cost of Water Infrastructure Modernization Project II, and it intends to apply part of the proceeds of this credit to payments under the Contract for Rehabilitation of Tsalka Water Supply System for *The United Water Supply Company of Georgia* (Contract # EIB/WIMPII/W/NCB/27).
- 2. *LEPL Municipal Development Fund of Georgia* now invites sealed bids from eligible and qualified bidders for works:

Rehabilitation of Tsalka Water Supply System

Main works under the project are:

- 1. Waterline I sector I central d=110; d=160; Σ L=4500 m extension to designed pipes of private houses 200 units, at existed pipes 570 units.
- 2. Waterline network II sector Tabidze street d=63; d=110; d=200; d=219/5; d=60/3; ΣL=3630 m extension to designed pipes of private houses 100 units, at existed pipes 30 units.
- 3. Pressure pipeline d=325/6; L=1000; d=159/4; L=2510; $\Sigma L=3510$.
- 4. Nardevani outfall utilities; captage #1; 2; 3; 4; drainage cell #1; 2; 3; electric supply, technology device of existed chlorinator with saline water electrolysis; drainage collector.
- 5. Central district designed reservoir w=500 m³. Repairs of existed guard cabin, toilet, supportive wall, driveway and electric supply.
- 6. Tabidze district w=250 m³ reservoir utilities: guard cabin, toilet, supportive wall, driveway, electric supply.
- 7. Railway intersection #1.
- 8. Intersection of drainage channels #1; #2;

The construction period is 18 (eighteen) months from start date of the works.

- 3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the EIB's *Guidelines: Guide to Procurement, June 2011* and is open to all bidders from Eligible Source.
- 4. Interested eligible bidders may obtain further information from *Municipal Development Fund of Georgia, Ilia Darchiashvili, Acting Executive Director, procurement@mdf.org.ge* and inspect the Bidding Documents at the address given below from Monday to Friday *10:00 to 18:00 hours*.

- 5. Qualifications requirements include and are not limited to:
 - (a) The minimum required average annual turnover of construction works for the successful Bidder in the last three years shall be: GEL 4,200,000;
 - (b) The minimum amount of liquid assets and/or credit facilities net of other contractual commitments shall be: GEL 700,000.
 - (c) A minimum number of similar contracts specified below that have been satisfactorily and substantially completed as a prime contractor, joint venture member, management contractor or sub-contractor between 1st January 2009 and application submission deadline: (i) 1 (one) contract, of minimum value of GEL 2,500,000; or (ii) 2 (two) contracts, each of minimum value GEL 1,250,000 but with total value of all contracts equal or more than GEL 2,500,000.

A margin of preference for certain goods manufactured domestically "shall not" be applied. Additional details are provided in the Bidding Documents.

6. A complete set of Bidding Documents in *English language* may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non refundable fee *GEL 300* or equivalent in a convertible currency plus currier expenses if a bidder would like the Bidding documents to be sent by Courier. On request, against a faxed copy of the evidence of the remittance, the Bidding Documents may be sent by courier service if the transport is previously ordered by the Bidder in his country. The Borrower bears no responsibility for the delivery in such a case.

All bids must be accompanied by a "Bid Security" of GEL 63,000 (Sixty Three Thousand) equivalent. A Bid-Securing Declaration is not required.
