- 1. Georgia has received a loan from the European Investment Bank (hereinafter referred to as "the Bank") toward the cost of Water Infrastructure Modernization Project II, and it intends to apply part of the proceeds of this credit to payments under the Contract for Rehabilitation of **Zestafoni** Water Supply System for *The United Water Supply Company of Georgia* (Contract # EIB/WIMPII/W/NCB/24-1).
- 2. *LEPL Municipal Development Fund of Georgia* (Employer) now invites sealed bids from eligible and qualified bidders for works:

Main works under the project are:

- 1. Removal of asphalt pavement 1,906 m³;
- 2. Soil excavation $-22,200 \text{ m}^3$;
- 3. Earth-fill and backfills 13,494 m³;
- 4. Sand bedding $-8,700 \text{ m}^3$;
- 5. Asphalt-concrete pavement 20,300 m²;
- 6. Polyethylene pipelines (network) PN10 PE-100 (d=400-50mm) 18,441 m;
- 7. Polyethylene pipes (connections) d=32mm-4,390m; d=25mm-17,870m;
- 8. Steel pipelines (d=273/5; 219/5; 159/4 mm) 4,000 m.

Works under this contract are expected to be implemented from October 2014 through January 2016.

The estimated cost of proposed works is **GEL 3,666,445.00** including all taxes, duties and other governmental levies as elaborated under Bidding Documents clause ITB - 14.7.

- 3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the EIB's *Guidelines: Guide to Procurement, June 2011* and is open to all bidders from Eligible Source.

- 5. Qualifications requirements include and are not limited to:
 - (a) The minimum required average annual turnover of construction works for the successful Bidder in the last three years shall be: **GEL 5,500,000**;
 - (b) The minimum amount of liquid assets and/or credit facilities net of other contractual commitments shall be: **GEL 900,000**.
 - (c) A minimum number of similar contracts specified below that have been satisfactorily and substantially completed as a prime contractor, joint venture member, management contractor or sub-contractor between 1st January 2009 and application submission deadline: (i) 1 (one) contract, of minimum value of GEL 2,900,000; or (ii) 2 (two) contracts, each of minimum value GEL 1,450,000 but with total value of all contracts equal or more than GEL 2,900,000.

A margin of preference for certain goods manufactured domestically "shall not" be applied. Additional details are provided in the Bidding Documents.
