1. The Government of Georgia has received financing from the Asian Development Bank (ADB) towards the cost of Sustainable Urban Transport Investment Program – Tranche 3. Part of this financing will be used for payments under contract named above. Bidding is open to Bidders from eligible source countries of the ADB.

2. The Municipal Development Fund of Georgia (MDF) (hereinafter referred to as the "Employer") invites sealed bids from eligible Bidders for the construction and completion of Construction of Coastal Protection Facility in Anaklia, Phase II, which includes the following key activities:

- Construction of 4 units of underwater breakwaters with total length of 1,130 meters, out of which the length of one section equals 230 meters, and the rest of three sections is 300 meters each. Underwater breakwaters consist of concrete tetrapod (total 6,444 pieces; 5 ton each)
- Beach line improvement with artificial nourishment of sand. Beach length is 1,430 meters, and amount of sand is 97,855 cubic meters.

3. International competitive bidding will be conducted in accordance with ADB's single-stage, two-envelope procedure and is open to all Bidders from eligible countries as described in the bidding document.

4. Only eligible Bidders with the following key qualifications should participate in this bidding

- Contract of Similar Size and Nature: Participation in at least one contract that has been successfully or substantially completed within the last 5 years and that is similar to the proposed works, where the value of the Bidder's participation exceeds US\$ 6.0 million. The similarity of the Bidder's participation shall be based on the physical size, nature of works, complexity, methods, technology or other characteristics as described in Section 6, Employer's Requirements.
- Construction Experience in Key Activities: Preparation and placement of 200 cubic meter of concrete per day under water.
- Average Annual Construction Turnover: Minimum average annual construction turnover of US\$20 million equivalent calculated as total certified payments received for contracts in progress or completed, within the last three years.
- Financial Resources: Cash flow requirement for subject contract is US\$ 2.5 million equivalent.
- Equipment Requirements: The following equipment are required but not limited to:
 - Bulldozer
 - Wheel Loader;
 - Barge including winches for installation of TTP
 - Barge for transportation of Materials and TTP

- Tugboat
- Motor boat
- Dumper trucks
- Crane
