Assignment Title: Consulting Services for Supervision of Civil Works (phase 1) to be implemented under Second Regional and Municipal Infrastructure Development Project (SRMIDP)

Georgia has received Credit from the World Bank (WB) and Grant from Swiss Development Cooperation (SDC) toward the cost of the Second Regional and Municipal Infrastructure Development Project, and intends to apply part of the proceeds for consulting services.

The consulting services ("the Services") include organizing day-to-day construction supervision of the civil works, which should be implemented in Georgia. The civil works contracts, to be supervised, will include a variety of works, such as roads, water and sanitation, wastewater treatment, solid waste management, street lighting, municipal markets, community facilities, bridges, tunnels, sport facilities, health and educational facilities, communication lines, gas supply, bank reinforcement.

The main objective of the assignment is to supervise the ongoing contracts of construction or/and rehabilitation works, as the Project Manager on behalf of the Employer Municipal Development Fund of Georgia (MDF) in accordance with the provisions of the signed contracts between MDF and the contractors in order to insure the following:

- a) High quality of construction in adherence to the valid standards of Georgia and international standards and best practices;
- b) Adherence to the requirements of valid design (draft, detailed), specifications and performance standards by implementation of the provisions of the technical specifications and other provisions of the construction contracts;
- c) Completion of works in accordance with the construction schedules of the construction contracts. That in turn will result in long-term sustainability and efficient operation of the completed works.
- d) Adherence to the World Bank safeguards policies.

In general, subprojects supervision of which envisaged under this assignment are located in various towns and villages of Georgia.

The tentative duration of the assignment is 12 months, commencing approximately in February 2015. SRMIDP envisages second phase of civil works, which currently are not included in the scope of supervision assignment. Based on the need and subject to satisfactory performance of the Consultant, the Client may extend the service of the consultant for the second phase of civil works packages based on the conditions of the initially negotiated contract.

The Municipal Development Fund of Georgia now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. Expression of interest should cover, but not limited to: corporate profile, years in business, experience relevant to the project activities, key staff resources, and core business. The shortlisting criteria are:

- Similar experience within the last 7 years (i.e. since January 2007). Similar experience implies
  experience in supervision of construction and rehabilitation works of buildings, roads and water
  supply systems.
- General experience.

The experience of sub-consultants will not be taken into account while evaluating the corporate experience of the consultant).
