1. Georgia has received financing from the World Bank toward the cost of the Second Regional and Municipal Infrastructure Development Project, and intends to apply part of the proceeds toward payments under the contract for Villages Salkhino-Letsave-Balda (Martvili municipality) road rehabilitation

The project envisages: Rehabilitation of Salkhino-Letsave-Balda road, with length 6611 m. The works involve rehabilitation of road pavement and installation of engineering structures (still pipes, concrete, lattice).

Main construction works:

1. Fragmented Crushed-rock - 7 072 m³
2. Sand-gravel - 9 611 m³
3. Coarse grained asphalt concrete - 33 055 m²
4. Fine grained asphalt concrete - 33 055 m²
5. Gabions - 220 m³
6. Metal pipes - 332 m
7. Concrete ditch - 20 m

The construction period is 6 (six) months from the start date of the works.

Qualifications requirements include and are not limited to:

- a. Minimum average annual turnover calculated as total certified payments received for contracts in progress or completed, within the last three (3) years (2011, 2012, 2013 years) shall be GEL 3,300,000;
- b. The Bidder must demonstrate access to, or availability of, financial resources such as liquid assets, unencumbered real assets, lines of credit, and other financial means, other than any contractual advance payments to meet the following cash-flow requirement GEL 750,000;
- c. Participation as contractor, management contractor, or subcontractor, in at least one (1) contract within the last three (3) years that has been successfully and substantially completed and that is similar to the proposed Works, with a value of at least GEL 1,800,000 or less than or equal to 3 (three) contracts, each of minimum value GEL 600,000 but with total value of all contracts equal or more than GEL 1,800,000

2. The Municipal Development Fund of Georgia now invites sealed bids from eligible bidders for **Villages Salkhino-Letsave-Balda (Martvili municipality) road rehabilitation**

3. Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank's *Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers*, January 2011 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
