# Water Infrastructure Modernization Project II Rehabilitation of Baghdati Water Supply System

- 1. Georgia has received a loan from the European Investment Bank (hereinafter referred to as "the Bank") toward the cost of Water Infrastructure Modernization Project II, and it intends to apply part of the proceeds of this credit to payments under the Contract for Rehabilitation of Baghdati Water Supply System for *The United Water Supply Company of Georgia* (Contract # EIB/WIMPII/W/NCB/04-2).
- 2. *LEPL Municipal Development Fund of Georgia* now invites sealed bids from eligible and qualified bidders for works:

# Rehabilitation of Baghdati Water Supply System

Main works under the project are:

### **Water Supply Network**

- 1. Soil excavation  $-4,358.0 \text{ m}^3$ ;
- 2. Filling the trench with sand  $-1,334.0 \text{ m}^3$ ;
- 3. Filling the trench with ballast 985.0 m<sup>3</sup>;
- 4. Polyethylene pipe D=25-280mm PE100 SDR17-PN10 4,201.0 m;
- 5. Steel pipe D=108-273mm 1,187.3 m.

## **Water Treatment Plant**

- 1. Soil excavation 282 m<sup>3</sup>;
- 2. Backfilling the soil  $-136.0 \text{ m}^3$ ;
- 3. Steel pipe D=219mm 56.0 m;
- 4.  $R/concrete works 50m^3$ ;
- 5. Arrangement of pumping, chlorination and sentry building 1pcs.

The construction period is 6 (six) month from start date of the works.

- 3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the EIB's *Guidelines: Guide to Procurement, June 2011* and is open to all bidders from Eligible Source.
- 4. Interested eligible bidders may obtain further information from *Municipal Development Fund of Georgia, Ilia Darchiashvili, First Deputy Executive Director, procurement@mdf.org.ge* and inspect the Bidding Documents at the address given below from Monday to Friday 10:00 to 18:00 hours.

- 5. Qualifications requirements include and are not limited to:
  - (a) The minimum required average annual turnover of construction works for the successful Bidder in the last three years shall be: **GEL 2,900,000.00.**
  - (b) The minimum amount of liquid assets and/or credit facilities net of other contractual commitments shall be: **GEL 320,000.00.**
  - (c) A minimum number of similar contracts specified below that have been satisfactorily and substantially completed as a prime contractor, joint venture member, management contractor or sub-contractor between 1<sup>st</sup> January 2009 and application submission deadline: (i) 1 (one) contract, of minimum value of **GEL 780,000.00**; Or (ii) Less than or equal to 3 (three), each of minimum value **GEL 260,000.00** but with total value of all contracts equal or more than **GEL 780,000.00**.

A margin of preference for certain goods manufactured domestically "shall not" be applied. Additional details are provided in the Bidding Documents.

6. A complete set of Bidding Documents in *English language* may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non-refundable fee *GEL 300* or equivalent in a convertible currency plus currier expenses if a bidder would like the Bidding documents to be sent by Courier. On request, against a faxed copy of the evidence of the remittance, the Bidding Documents may be sent by courier service if the transport is previously ordered by the Bidder in his country. The Borrower bears no responsibility for the delivery in such a case.

All bids must be accompanied by a "Bid Security" of **GEL 19,000** (**Nineteen Thousand**) equivalent. A Bid-Securing Declaration is not required.
