Main works under the project are:

- 1. Excavation of the III category soil and disposal at 3km distance 4,100m³;
- 2. Backfilling of soil by bulldozer and manually 1,159m³;
- 3. Arrangement of the gravel layer for asphalting with 0,1m thickness 17m³;
- 4. Arrangement of the sand layer for the pipelines -2,023 m³;
- 5. Reinstatement of the 2-layer asphalt pavement 84m²;
- 6. Installation of steel pipeline (d=159mm) 2,291m;
- 7. PE pipe PN10 PE100 d=20-110mm 2,768m.

Works under this contract are expected to be implemented from July 2014 through March 2015.

- 3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the EIB's *Guidelines: Guide to Procurement, June 2011* and is open to all bidders from Eligible Source.

 - (b) The minimum amount of liquid assets and/or credit facilities net of other contractual commitments shall be: GEL 400,000.

A margin of preference for certain goods manufactured domestically "shall not" be applied. Additional details are provided in the Bidding Documents.
