

Invitation for Bids

Contract Title: Rehabilitation of Theatre and Municipality Building in Tskaltubo Town Reference No. IDA/RDPII/CW/NCB/15-2014

1. The Georgia has received financing from the World Bank toward the cost of the Regional Development Project II, and intends to apply part of the proceeds toward payments under the contract for **Rehabilitation of Theatre and Municipality Building in Tskaltubo Town**

The project envisages: rehabilitation of municipality building facades and interior, which is situated in the center of town Tskaltubo and as well as theatre building facades.

Volumes of Main Civil Works:

- 1. Monolith concrete and reinforcement constructions arrangement 132.89 m³;
- 2. Metal constructions arrangement -7.25 t;
- 3. Roof arrangement with metal tiles -400.00 m^2 ;
- 4. Roof decking repair 1,200.00 m²;
- 5. Wall plastering with sand cement mortar -1,213.54 m²;
- 6. Façade relief plastering (so called "Munich") 1,488.00 m²;
- 7. Facing works with natural stone -779.85 m^2 ;
- 8. Floor arrangement with ceramic and artificial granite tiles 635.25 m²;
- 9. Facing parapet with aqua panel 665.00 m²;
- 10. Ceiling arrangement with "Arsmtrong" and plaster boards 1,611.00 m²;
- 11. Door arrangement works by specific high quality wooden material 184.11 m²
- 12. Floor arrangement with laminated parquet -374.80 m^2 ;
- 13. Metal plastic window block arrangement (by wooden imitation, glass 4/6mm) 178.08 m²;
- 14. Granite curbs arrangement 210.00 m;
- 15. MDF door block arrangement 156.42 m²;
- 16. Installation of dark grey aluminum vitrages, glass unit 4/6mm with shady glass and accessories 230.00 m²;

The construction period is 7 (seven) months from start date of the works.

The estimated cost of proposed works is *GEL 1,335,624.64* including all taxes, duties and other governmental levies as elaborated under clause ITB - 14.7. However it is the responsibility of the bidder to submit a bid price, which could be below or above the estimated cost, based on the current market prices and any other factors which may influence the pricing of the proposed works.

Qualifications requirements include and are not limited to:

- a. Minimum average annual turnover calculated as total certified payments received for contracts in progress or completed, within the last three (3) years shall be GEL 3,500,000;
- b. The Bidder must demonstrate access to, or availability of, financial resources such as liquid assets, unencumbered real assets, lines of credit, and other financial means, other than any contractual advance payments to meet the following cash-flow requirement GEL 550,000;
- c. Participation as contractor, management contractor, or subcontractor, in at least one (1) contract within the last three (3) years that has been successfully and substantially completed and that is similar to the proposed Works, with a value of at least GEL 1,000,000, or less than or equal to 3 (three) contracts, each of minimum value GEL 340,000 but with total value of all contracts equal or more than GEL 1,000,000,000.
- 2. The Municipal Development Fund of Georgia now invites sealed bids from eligible bidders for **Rehabilitation of Theatre and Municipality Building in Tskaltubo Town**
- 3. Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank's *Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers,* January 2011 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
- 4. Interested eligible bidders may obtain further information from Municipal Development Fund of Georgia at the address below and inspect the bidding documents during office hours 10:00 to 18:00 hours at the address given below.
- 5.
