

## **Invitation for Bids**

1. The Georgia has received financing from the World Bank toward the cost of the Second Regional and Municipal Infrastructure Development Project, and intends to apply part of the proceeds toward payments under the contract for Gurjaani (Kakheti) streets and v. Mirzaani (Dedoplistskaro) road rehabilitation

The project foresees the completion works related to the rehabilitation of Gurjaani (Kakheti) streets and v.Mirzaani (Dedoplistskaro) road.

## Main construction woks:

- 1. Fragmented Crushed-rock 23 395 m<sup>2</sup>
- 2. Sand-gravel mix 693 m<sup>2</sup>
- 3. Coarse grained asphalt concrete mix 20 720 m<sup>2</sup>
- 4. Fine grained asphalt concrete mix 25 635 m<sup>2</sup>;
- 5. Arrangement of waste water system 773 m
- 6. Arrangement of curbs 3859 m
- 7. Concrete triangle ditch 110.5 m<sup>3</sup>
- 8. Inspection hole 32 count

The construction period is 5 (five) months from the start date of the works.

The estimated cost of proposed works is GEL 1, 578, 013 including all taxes, duties and other governmental levies as elaborated under clause ITB - 14.7. However it is the responsibility of the bidder to submit a bid price, which could be below or above the estimated cost, based on the current market prices and any other factors which may influence the pricing of the proposed works.

Qualifications requirements include and are not limited to:

- a. Minimum average annual turnover calculated as total certified payments received for contracts in progress or completed, within the last three (3) years shall be GEL 2,400,000;
- b. The Bidder must demonstrate access to, or availability of, financial resources such as liquid assets, unencumbered real assets, lines of credit, and other financial means, other than any contractual advance payments to meet the following cash-flow requirement GEL 650,000;
- c. Participation as contractor, management contractor, or subcontractor, in at least one (1) contract within the last three (3) years that has been successfully and substantially completed and that is similar to the proposed Works, with a value of at least GEL 1,262,400 or less than or equal to 2 (two) contracts, each of minimum value GEL 800,000 but with total value of all contracts equal or more than GEL 1,262,400
- 2. The Municipal Development Fund of Georgia now invites sealed bids from eligible bidders for Rehabilitation of Gurjaani (Kakheti) streets and v. Mirzaani (Dedoplistskaro) road
- 3. Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank's <u>Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers</u>, January 2011 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
- 4. Interested eligible bidders may obtain further information from Municipal Development Fund of Georgia at the address below and inspect the bidding documents during office hours 10:00 to 18:00 hours at the address given below.
- 5.
