- 4. Reinstatement of asphalt-concrete pavement 1,383m²;
- 5. Backfilling of the ballast 1,231m³;
- 6. Backfilling of the soil -11,354m³;
- 7. Installation of PE pipelines (DN20-225, PE100 PN10-16; SDR17-11) 4,167.6m;
- 8. Installation of steel pipelines D=250 D=500 mm 4,067m.

Works under this contract are expected to be implemented from August 2014 through April 2015.

 - (b) The minimum amount of liquid assets and/or credit facilities net of other contractual commitments shall be: GEL 750,000.

A margin of preference for certain goods manufactured domestically "shall not" be applied. Additional details are provided in the Bidding Documents.
