- 1. Georgia has received a loan from the European Investment Bank (hereinafter referred to as "the Bank") toward the cost of Water Infrastructure Modernization Project II, and it intends to apply part of the proceeds of this credit to payments under the Contract for Rehabilitation of **Akhaltsikhe and Aspindza** Water Supply Systems for *The United Water Supply Company of Georgia* (Contract #EIB/WIMPII/W/NCB/30).
- 2. *LEPL Municipal Development Fund of Georgia* (Employer) now invites sealed bids from eligible and qualified bidders for works:

### Rehabilitation of Akhaltsikhe and Aspindza Water Supply Systems

Main works under the project are:

- 1. Removal of asphalt layer 416.7 m<sup>3</sup>;
- 2. Excavation of III category soil 7,988 m<sup>3</sup>;
- 3. Excavation of V category soil 10,330 m<sup>3</sup>;
- 4. Backfilling the excavated soil 9,269 m<sup>3</sup>;
- 5. Arrangement of gravel layer for asphalting 393 m<sup>3</sup>;
- 6. Arrangement of gravel layer for the pipeline  $-5,453 \text{ m}^3$ ;
- 7. Arrangement of the asphalt pavement 4,251 m<sup>2</sup>;
- 8. Cutting off the subscribers from the existing main line and connection to the water supply network 55 subscribers:
- 9. Polyethylene pipelines (SDR 17 PN10 SDR 11 PN 16, PE100 d=20-110mm) 20,729 m.
- 10. Installation of steel pipelines 2,291 m.

Works under this contract are expected to be implemented from **September 2014** through **July 2015**.

The estimated cost of proposed works is **GEL 1,911,926.00** including all taxes, duties and other governmental levies as elaborated under Bidding Documents clause ITB - 14.7.

- 3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the EIB's *Guidelines: Guide to Procurement, June 2011* and is open to all bidders from Eligible Source.

- 5. Oualifications requirements include and are not limited to:
  - (a) The minimum required average annual turnover of construction works for the successful Bidder in the last three years shall be: **GEL 4,600,000**;
  - (b) The minimum amount of liquid assets and/or credit facilities net of other contractual commitments shall be: **GEL 600,000**.

(c) A minimum number of similar contracts specified below that have been satisfactorily and substantially completed as a prime contractor, joint venture member, management contractor or sub-contractor between 1<sup>st</sup> January 2009 and application submission deadline: (i) 1 (one) contract, of minimum value of GEL 1,500,000; or (ii) 2 (two) contracts, each of minimum value GEL 750,000 but with total value of all contracts equal or more than GEL 1,500,000.

A margin of preference for certain goods manufactured domestically "shall not" be applied. Additional details are provided in the Bidding Documents.

A complete set of Bidding Documents in *English language* may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non refundable fee *GEL 300* or equivalent in a convertible currency plus currier expenses if a bidder would like the Bidding documents to be sent by Courier.
