1. Georgia has received a loan from the European Investment Bank (hereinafter referred to as "the Bank") toward the cost of Water Infrastructure Modernization Project II, and it intends to apply part of the proceeds of this credit to payments under the Contract for Rehabilitation of Tsnori Water Supply System for *The United Water Supply Company of Georgia* (Contract # EIB/WIMPII/W/NCB/05).
2. *LEPL - Municipal Development Fund of Georgia* (Employer) now invites sealed bids from eligible and qualified bidders for works:

Rehabilitation of Tsnori Water Supply System

Main works under the project are:

1. Removal and disposal of old asphalt layer - 3,750m³;
2. Excavation of the IV and V category soil - 59,850m³;
3. Disposal of the soil - 36,450m³;
4. Backfilling the trench - 25,500m³;
5. Arrangement of metal road base layer for asphalt pavement - 4,500m³;
6. Arrangement of the sand bedding for the pipelines - 23,050m³;
7. Arrangement of the 2-layer asphalt pavement – 26,700m²;
8. Filling the trench with ballast – 8,300m³;
9. Construction of new boreholes – 3 units;
10. Construction of steel pipelines: d=325/6 mm – 2,650m; d=273/5 mm, - 1,600m;
11. Construction of gravity pipelines PE-100, D=250 PN10 – 1,470 m;
12. Polyethylene pipe (Network) PN10; PN12.5 PE100 d=63-200mm - 63,705m;
13. Polyethylene pipe (Connections) PN10 d=25 - 27,600 m; PN12.5 d=25 - 14,550 m.

Works under this contract are expected to be implemented from July 2014 through May 2016.

3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the EIB's *Guidelines: Guide to Procurement, June 2011* and is open to all bidders from Eligible Source.
4. Interested eligible bidders may obtain further information from *Municipal Development Fund of Georgia, Teimuraz Murgulia, Acting Executive Director*, procurement@mdf.org.ge and inspect the Bidding Documents at the address given below from Monday to Friday 10:00 to 18:00 hours.
5. Qualifications requirements include and are not limited to:
 - (a) The minimum required average annual turnover of construction works for the successful Bidder in the last three years shall be: GEL 6,800,000;
 - (b) The minimum amount of liquid assets and/or credit facilities net of other contractual commitments shall be: GEL 1,500,000.

A margin of preference for certain goods manufactured domestically "shall not" be applied. Additional details are provided in the Bidding Documents.

6. A complete set of Bidding Documents in **English language** may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non refundable fee **GEL 300** or equivalent in a convertible currency plus carrier expenses if a bidder would like the Bidding documents to be sent by Courier. Based on written request, against presented evidence of the remittance, the Bidding Documents may be sent by courier service if the transport is previously ordered by the Bidder in his country. The Employer bears no responsibility for the delivery in such a case.

Bids will be opened in the presence of the bidders' representatives who choose to attend in person address below at 15:00 (local time), May 19, 2014.

All bids must be accompanied by a “Bid Security” of **GEL 166,000 (One Hundred Sixty Six Thousand)** equivalent. A Bid-Securing Declaration is not required.
